2021 TAX COLLECTION INFORMATION



WAYS TO PAY YOUR TAXES

Due to the continuing COVID-19 pandemic we strongly encourage you to pay your taxes by one of the following methods rather than coming in person to Village Hall. You may receive a receipt by enclosing a self-addressed stamped envelope. You may also check online at <u>https://www.co.polk.wi.us/</u>, click on property tax search on the left-hand side to see if your payment was received and applied. Please allow time for the payment to show up online.

U.S. MAIL

For income tax purposes, any end-of-month tax payments received after 12/31 but "<u>postmarked</u>" by December 31, 2021 will be receipted "December 31, 2021".

24 HOUR DROP OFF

A drop box is located on the east side of Village Hall – at 310 Chieftain Street. The drop box is checked daily and tax payments found in the drop slot will be receipted daily using that day's date or if on a weekend or holiday the following business day.

ON-LINE

You may pay your taxes on-line with your debit card, credit card or e-check thru www.paymentservicenetwork.com They charge a convenience fee.

Receipts for tax payments and dog licenses will be mailed out only to those individuals that furnish a selfaddressed stamped envelope.

LOTTERY CREDIT If this tax bill is for your primary residence and you have resided there since January 1, 2021(or before) and there is <u>NOT</u> a lottery credit deduction on your tax bill, please call the Village Office at (715)294-3498 to get the required form to claim this credit. **The lottery credit for this year is \$207.69**. PLEASE DO NOT WAIT UNTIL THE LAST MINUTE TO APPLY FOR THE LOTTERY CREDIT.

DOG LICENSING Dog licenses are required in the Village of Osceola. Dog licenses must be obtained prior to April 1, 2022. Per state statues and Village ordinances <u>dog licenses will not be issued without complete rabies information</u>. Please call your veterinarian for a copy of your rabies vaccination certificate if you do not have one. Due to the COVID-19 pandemic we prefer you apply for and receive your dog license by mail.

POLICE REMINDER

ALL-NIGHT PARKING –Village Code prohibits the parking of unoccupied vehicles on any Village Street, or in a Village parking lot, between the hours of 2:00 a.m. and 6:00 a.m. from November 15 through April 15. Winter parking restrictions are in effect and enforced during that time, even if there is no snow. Vehicle owners are subject to towing, storage charges and a parking ticket.

PUBLIC WORKS

The Village of Osceola Public Works Department has had a very successful 2021. The department went beyond regular and daily maintenance responsibilities to include excellent internal projects to parks, streets, and infrastructure to make the Village of Osceola a better place to live.

Some noteworthy highlights include a new steel roof on the Schillberg Park pavilion, a newly installed fence at Gristmill Park and composite decking to the Cascade Falls overlook. Storm sewer repairs, crack filling and spray patching our streets were all part of our maintenance and preventative maintenance plan to maintain our infrastructure.

We look forward to 2022 and would like to thank all Village of Osceola residents and visitors for the continued support in our efforts in maintaining the Village of Osceola.

Here are a few reminders to all residents and business owners now that we have officially moved into the winter season.

Mailboxes should be of sturdy materials and installed appropriately in accordance with USPS standards. Mailboxes and the posts they mount on degrade with time in the elements of Northwest Wisconsin. They suffer wind, rain, snow and the wintry blast of snow and ice from the plows maintaining the streets. Village of Osceola Ordnance 186-6

The owner, occupant, or person in charge of each and every building, structure, or unoccupied lot in the Village fronting or abutting any street shall clean, or cause to be cleaned, the sidewalk in front of or adjoining each such building, structure or lot of snow or ice to the width of such sidewalk within 24 hours after the cessation of a snowfall. If ice has so formed that it cannot be removed, the owner or occupant shall keep the same sprinkled with ashes, salt, sawdust or sand.

No person or persons owning or leasing any private or commercial property shall clear their property, including parking areas, lots and driveways, but except sidewalks, of accumulated snow, ice or other debris onto any Village Street or other Village property. Snow shall not be piled at or near intersections so as to obstruct the view of pedestrians or operators of motor vehicles.

The deposit of snow or ice upon any sidewalk, alley or street of the Village contrary to the provisions of this section shall be and is declared to be a nuisance and, in addition to the penalty provided for violation of this section, the Village Administrator or designee may cause any snow or deposited to be removed and cause the cost of said removal to be charged to the owner of the property from which said snow or ice has been removed. If not paid within 30 days, the cost of the removal shall be added to the tax roll as a special tax or recovered in an action against the owner or occupant.

SEWER MAINANENCE AND REPAIR

What Is A Building Sewer? A building sewer is the pipe that connects a building's plumbing system to the main sanitary sewer. Building sewers are also called "service laterals", "house laterals", or "sewer laterals." The main sanitary sewer is usually located in the street and collects wastewater, called sewage, from building sewers and conveys it to the wastewater treatment plant.

Why Do Building Sewers Need Maintenance? Blockages in your building sewer can cause backups of sewage from your building's toilets, showers, and floor drains. These types of blockages are sometimes referred to as basement backups. A backup of sewage can lead to disease, destruction of valuables, damage to your property, and electrical malfunctions. Rubbish and other objects often combine with hair, grease and other debris to cause clogging of the sewer system. Even something as small as a cotton tip swab with other attached debris can clog sewer building sewers. Cracked building sewers allow groundwater to enter the sewer system, which can also cause a basement backup.

SEWER MAINTANENCE AND REPAIR

What Are Sewer Cleanouts? Building sewers often have cleanouts which provide a point of access for cleaning and repair. One cleanout is located immediately inside the building or just outside the building wall. There may be additional cleanouts between the building wall to the main sewer. The cleanout is usually a small pipe about 4 inches in diameter within a frost sleeve. There should be a cap on the cleanout.

What Problems Should I Look For? 1) Waste water backups inside the building. 2) Slow draining sinks and toilets. 3) Water leaking from cleanouts, outside drains or main sewer manhole covers. 3) Unusual odors or sewage smells in or around your home or business. If you suspect you have a blockage or problem in your building sewer, call a professionally licensed plumber for an inspection. Even if you aren't experiencing drain or sewer problems, periodic inspections and cleaning by a professionally licensed plumber are a good idea. Building sewers are usually neglected by homeowners until problems arise. Simple maintenance and timely repairs can avoid sewage backups and damage to your property and personal belongings.

How Can I Prevent Problems? Dos: 1) Place paper towels, feminine products, disposable diapers, dental floss, plastics and other personal hygiene products in a wastebasket. 2) Use sink and shower drain strainers. 3) Collect grease and fats in a heat-resistant container, cool and dispose of it in your garbage with solid waste. 4) Choose the most appropriate method of disposal for food scraps: composting; in the garbage for solid waste disposal; or down the sink by grinding with a garbage disposal unit. **Don'ts:** 1) Don't use the toilet as a wastebasket for garbage, medications, or chemicals! 2) Don't plant trees or large shrubs near sewer lines where roots can penetrate and create a dense mat of "root balls." 3) Don't pour grease, fats or oils from cooking down the drain. Grease in drains collects and hardens into a plug. 4) Don't connect French drains, roof gutters, sump pumps and other flood control systems to your sanitary sewer. These types of connections are illegal.

Why Are Infiltration and Inflow Big Problems? Infiltration and inflow (I/I) are terms referring to groundwater and/or rainwater that enters the sanitary sewer system through cracked pipes, leaky manholes, roof and gutter downspouts, sump pumps, foundation drains, and improperly connected storm drains. Most infiltration comes from groundwater, and most inflow comes from rainwater and/or snowmelt. Extensive studies have shown that as much of 40% of I/I enters the collection system from building sewers. Additional I/I flow in the sanitary sewer collection system results in the need for larger sewers and treatment plants. Higher sewer user fees must be collected to treat the increased volume of wastewater from I/I.

What Can I Do To Prevent And Reduce Infiltration And Inflow? 1) Make sure the cap to any cleanout is secure and has not been damaged. 2) Disconnect outdoor patio, deck, yard or garage drains that may be connected to the building sewer. 3) Reroute sump pump discharges from basement or foundation drains entering building sewer connections to outdoor lawn areas or storm drains. 4) Redirect rain gutters and downspouts connected to the building sewers to rain gardens, lawns, or storm drains.

Who Is Responsible For Maintaining and Repairing The Building Sewer? Property owners are usually responsible for maintaining and repairing building sewers. If your building sewer needs maintenance or repair, always call the Village to verify local requirements. The Village may also want to perform an inspection, prior to repair, to identify if there is a problem in the main sanitary sewer pipe. The installation and maintenance of the building sewer is regulated by the Department of Commerce, Safety and Buildings Division.
