PUBLIC WORKS REMINDERES



BRUSH PICK-UP - Brush chipping for residents within the Village of Osceola will begin Monday October 25th and will continue through the week, ending on Friday October 29th. If it is not curbside during that week, IT WILL NOT BE PICKED UP. All brush must be less than 3" in diameter and 6" in length and stacked neatly and parallel to the curb. No shrubs, trees, or stumps with attached roots will be picked up nor chipped.

<u>LEAF PICK-UP</u> - Leaves will be picked up as time permits **beginning Monday October** 25th and running through November 8th. Leaves **MUST** be in **biodegradable paper** bags and placed along the curb. We **WILL NOT** pick up plastic bags, bags with grass or mixed materials, or bags weighing more than 40 lbs.

TRASH RECEPTACLES - With winter approaching this is a reminder to adhere to Waste Management Policy in the placement of your trash receptacle. Public Works deems these an obstruction in streets, sidewalks, and lots while conducting snow removal and street sweeping efforts. During pick-up days it is appropriate for your receptacle to be in your driveway or on the boulevard.

<u>SIDEWALK SNOW REMOVAL</u> – The Village Code requires the owner, occupant, or person in charge of every building, structure to include an unoccupied lot in the Village to clean the snow and ice from the entire width of the sidewalk in front of the building within 24 hours after the cessation of a snowfall. If any ice cannot be removed, the owner or occupant is required to sprinkle the ice with ashes, salt, sawdust, or sand.

SNOW, LEAVES AND OTHER DEBRIS REMOVAL – Village Code requires that no person shall clear their property of accumulated snow, ice, leaves, lawn clippings or other debris onto any village street or other village property. Snow shall not be piled at or near intersections so as to obstruct the view of pedestrians or operators of motor vehicles. The failure to clear sidewalks and/or depositing snow, ice or leaves upon any sidewalk, alley, or street of the Village is a public nuisance. The Village Administrator, or designee, may cause any snow, ice or leaves deposited to be removed and cause the cost of said removal to be charged to the owner of the property from which said snow, ice or leaves has been removed. If not paid within 30 days, the cost of the removal shall be added to the tax roll as a special tax or recovered in an action against the owner or occupant.

<u>RIGHT-OF-WAY TREE TRIMMING</u> - Public Works will be conducting right-of-way trimming or removal of trees and shrubs through the fall and into early winter. Public and private trees or shrubs impeding roads and sidewalks preventing pedestrians, vehicles, line of sight and equipment from safe travel will be trimmed appropriately. Work conducted conforms to Village Code Chapter 124.

NEW OPENING OF THE NATURAL DEBRIS SITE OCTOBER 18TH, 2021 The Village of Osceola Public Works Department is excited to announce the opening of a light brush and leaf bag only drop-off site located at the Public Works Facility 107 Depot Road. This site is available for Village of Osceola residents only and may be asked to provide name and address while utilizing the site.

The entrance and exit of the site are signed appropriately on the gate located on the east side of the building. Currently the planned hours of operation are weekdays 7:30a.m. to 3:00p.m. The site will be closed for observed holidays and at times regular maintenance. Hours will be strictly enforced. Please look for any updates related to the site on the Village of Osceola webpage as hours may change seasonally.

Rules:

- 1) No garbage
- 2) No brush over 6 inches diameter or 6 feet in length
- 3) Leaf bags will only be in paper biodegradable bags with no mixed materials
- 4) No stumps or roots
- 5) No cutting of wood or chainsaws
- 6) No equipment or implements

The Public Works Department looks forward to a Natural Debris Site for residents to utilize and to help create an organic system with rich benefits including free compost soils and woodchips. Please help in maintaining this site by following the simple rules listed. By doing so we can look forward to a site with permanence.

2022 PROPERTY ASSESSMENT YEAR

The Village of Osceola will be conducting a total property revaluation for the 2022 assessment year. All properties will be updated to reflect the current real estate market. Estimating the market value is a matter of determining the price a typical buyer would pay for the property in its present condition. Updating property values is a process that does not generate additional tax revenue. The objective in updating properties to their current market value is ensuring fairness and equity to all.

Beginning in fall of 2021 we will be conducting a field review to verify information on all improvements (i.e., buildings) and land. If you are not home when the field review is being done, we will leave a notice on your door to let you know we were on your property to conduct our review. If you have any concerns about our field work process or need to provide us with additional information regarding your property, please feel free to call at 715.294.3498 or email at info@myosceola.com.

State Law requires assessments to be based on actual view of the property, or best information available. If we are not able to perform an on-site inspection of the property, we will determine the assessment by using existing records and our judgement concerning conditions and features. Please note the Assessor has certain statutory authority to enter land as described in Sections 943.13 and 943.15, Wisconsin Statutes.

THERE'S BEER IN THAT THAR BLUFF, by Deb Rose

Few places in the United States are as identified with beer as Wisconsin. Brewing beer has been a Wisconsin tradition dating back to the 1830s. Over the last couple of centuries our state has been home to some of the biggest and most renowned breweries in the country. Along with cheese and bratwurst we claim it as part of our identity. Shoot, even our baseball team, the Milwaukee Brewers, pays homage to our favorite barley and hop drink! Recent history has been filled with the explosion of craft beers and local breweries. Seems nearly every small town or city neighborhood has a brew pub. Although we don't currently have one in town, back in the day Osceola had its own craft beer brewed by local brewer Veit Geiger.

When he first came to town Geiger worked in a brick yard, later as a farmer and after returning from serving in the Civil War he started a brewery. From 1867 to about 1878 or so he operated Geiger Brewery near the bottom of the bluff just off of what is now Hwy 243. As the sign near the ruins of the old brewery says, that spot was chosen because the "artesian springs assured an abundant source of pure water, and the nearby caves provided a constant 50-degree storage cellar." Geiger built a saloon in Osceola on the northwest corner of what is now 2nd and Cascade, my guess is so he'd have a place to sell his wares! Later when the building housed the Polk County Court house the story goes those old kegs had to be moved from the basement to make room for the jail.

Although we no longer are the home to a brewery you can still see the ruins at the base of the bluff. A stream still runs through the area feeding the Cascade Falls and the springs in that area are still as pure as can be. A good friend who home brews started his 100th batch of beer in the shadow of the old brewery using the clear spring waters. Next time you are taking a hike around the bluff or near the falls add a little extra time to your venture and take a look at this cool little piece of lost Osceola history...and if you happen to use the springs for a batch of beer, I'm good at sampling!
